- Flight training landing fees are for domestic landings conducted exclusively for the purpose of improving the skill and knowledge of the flight crew of an Air Carrier licensed pursuant to Part II of the Canada Transportation Act, 1996, and where arrangements are made in advance with Hamilton International Airport Limited.
- Technical Flight landing fees apply to non-revenue landings of Signatory Air Carriers only. A non-revenue flight is one in which neither the inbound or outbound flight is conducted for revenue purposes, and where arrangements have been made in advance with Hamilton International Airport Limited.
- Licensing Flights are those conducted with a Transport Canada inspector on board. Inspector number to be provided along with flight identification.

3. GENERAL TERMINAL FEES
